Purpose:

To honor those who, through the years, by their achievements, service, contributions and devotion have been instrumental in the betterment and advancement of the sport of bowling in the Fayetteville area.

Nominations:

Any current member of the Fayetteville USBC Association, Inc. may nominate a person for induction into the Fayetteville USBC Association, Inc. Hall of Fame. The nomination must be submitted to the Hall of Fame Committee and must include a signed résumé explaining why the nominee should be considered for induction into the Hall of Fame. In addition, the person recommending the nominee should include the category the nominee is to be considered for.

Categories:

- 1) **Meritorious Service:** Bowlers who have contributed outstanding service to the FUSBCA, Inc. (living or posthumous).
- 2) **Superior Performance:** Bowlers who have shown superior performance on the lanes in the game of American Tenpin (living or posthumous).

Examples:

Fifteen (15) years as a sanctioned ABC/USBC/WIBC/YABA bowler or has served at least four (4) years as a member of the FBA/FWBA/FUSBCA Board of Directors, has participated in five (5) or more of one of the Fayetteville Adult Handicap Championships Tournaments (Open and/or Women's), has bowled in at least five (5) Mixed Doubles Tournaments of Fayetteville, their individual achievements, sportsmanship, dedication to and promotion of the sport of bowling (annual meeting, board meetings, workshop or/and other FUSBCA sponsored events).

Election Procedures:

- 1) After consideration and research, the selection committee will then submit its recommendations to the FUSBCA board of Directors. The Board of Directors will then vote and elect those considered worthy of Hall of Fame Membership.
- 2) In order to be elected, a nominee must receive a minimum of two thirds (2/3) of ballot votes cast by the Board of Directors.

Limitations:

- 1) The maximum number of nominees elected as a Hall of Fame Member shall be two (2) per year.
- 2) There shall be no minimum number of nominees required to be elected as a Hall of Fame Member.

Deadline for Submission:

All nominations, complete with résumé (filled out completely), must be submitted no later than **July the 31st**, annually. Address a sealed envelope to the "**FUSBCA Hall of Fame Committee**" and place in any drop box located in all Fayetteville bowling centers or hand delivered to any FUSBCA Director.
